Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Sub-section (1) of section 14 of the Disaster Management Act, 2005 (Central Act 53 of 2005) empowers the State Government to establish a State Disaster Management Authority for the State by notification in the official Gazette. Government have established the said Authority by notification issued under G. O. (P) No. 5/2011/DMD dated 3rd January, 2011 published as S.R.O. No. 7/2011 in the Kerala Gazette Extraordinary No. 14 dated 5th January, 2011. One of the non-official members of the said authority nominated under clause (i) of sub-rule (1) of rule 3 of the Kerala State Disaster Management Rules, 2007, retired and the other non-official member has not attended a single meeting. Therefore, the Government have decided to re-constitute the authority with the aforesaid members in accordance with the said rules.

This notification is intended to achieve the above object.
