Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Sub-section (1) of section 25 of the Disaster Management Act, 2005 (Central Act 53 of 2005) empowers the State Government of establish a District Disaster Management Authority for every Districts in the State by notification under sub-section (1) of section 14 establishing the State Disaster Management Authorities. As per notification G. O. (P) No. 154/2007/DMD dated 4th May, 2007 issued as S. R. O. No. 395/2007 and published in the Kerala Gazette Extraordinary No. 838 dated 4th May, 2007, Government of Kerala had established "The Kerala State Disaster Management Authority". Now, the Government have decided to establish District Disaster Management Authority for every Districts.

This notification is intended to achieve the above object.
