Incident Response System (IRS) was introduced in India in 2010 by the National Disaster Management Authority (NDMA). It is an effective mechanism for reducing the scope for adhoc measures in disaster response. It incorporates all the tasks that may be performed during DM irrespective of their level of complexity. It envisages a composite team with various sections to attend to all the possible response requirements. If IRS is put in place and stakeholders trained and made aware of their roles, it will greatly help in reducing chaos and confusion during the response phase. Everyone will know what needs to be done, who will do it and who is in command etc. IRS is a flexible system with Sections, Branches and Units with preassigned roles and responsibilities. Various Sections, Branches and Units will be activated based on the need of the situation and only as and when they are required.

The management of response in disasters requires the existing administrative set up, civil society and its various institutions to carry out a large number of tasks. The activities involved in response management would depend on the nature and type of disaster. It has been observed that in times of disaster, apart from lack of resources, lack of coordination among various agencies and an absence of role clarity amongst various stakeholders pose serious challenges. If the response is planned and the stakeholders are trained, there will be no scope for adhoc measures and the response will be smooth and effective.

The District Disaster Management Authority (DDMA), Kasaragod had taken the pioneering and exemplary step of constituting an Incident Response System(IRS) in the district. *The Orange Book of Disaster Management* has mandated the District Disaster Management Authorities to issue updated orders w.r.t IRS structure at the District and Taluk levels with roles and responsibilities of the various functionaries, as envisaged in the *National Disaster Management Guidelines – Incident Response System, 2010* of the National Disaster Management Authority. The following officers are designated as the functionaries in the District and Taluk levels as mentioned below:

All the officers designated as different functionaries are advised to go through the guidelines of IRS issued by NDMA and the Orange Book of Disaster Management issued by KSDMA. The CEO, DDMA is authorized to conduct as many training sessions to these officers and their supporting staff and also the officers at lower levels so that the system can be implemented in its full sense.

At the Taluk level, the respective heads of the departments should ensure that no officer nominated within the IRS is deputed for more than a span of 12 hours at a stretch and should facilitate the deployment of personnel on shift basis as and when needed. Also the Heads of the Department shall inform the District Disaster Management Authority duly regarding any change in the officers deputed in the Incident Response System (IRS) owing to transfer, promotion etc.

Training will be imparted to the newly appointed officers through the DDMA and will be duly
