ORDER

As per the Minutes read as first paper above, the State Executive Committee approved to open a fixed bank account in the joint name of Principal Secretary, Revenue & Disaster Management and the Head (Scientist), State Emergency Operations Centre, Department of Disaster Management and deposit the presently available funds from non governmental sources and the funds received as consultancy and management fees for projects funded by non-governmental sources (Project funded by United Nations Development Programme(UNDP), United Nations Environment Programme (UNEP), World Bank, JAICA etc) into this corpus fund.

The Head (Scientist) SEOC has requested to permit State Emergency Operations Centre to create a corpus fund with the following guidelines.

◆ Name of the fund: Corpus Fund for State Emergency Operations Centre, Dept. of Disaster Management, Govt. of Kerala

◆ Held as: Interest bearing long term Fixed Deposit in State Bank of India ✓

◆ Account holder: Joint account of (1) Principal Secretary, Revenue and Disaster Management, Govt. of Kerala and (2) Head (Scientist), State Emergency Operations Centre

Sources of funds:

- i. Non-governmental sources only. Consultancy and management fees for projects funded by non-governmental sources (projects funded by UNDP, UNEP, World Bank, JAICA etc.)
- ii. Remaining balance of expired projects of UNDP amounting to Rs.7,16,052/-
- Usage of interest from the corpus fund:
 - i. To be credited to account No. 33031314643 of State Emergency Operations Centre at SBI, Maruthamkuzhy
 - ii. To be used for purposes recommended by the Research and Management Council of SEOC constituted vide GO(Rt)No. 1941/2012/DMD dated 21.03.2012, for the smooth functioning of SEOC

iii. In case the RMC does not intent to utilize the interest of a given year, the same may be credited back to the corpus fund and added to the fixed deposit.

Government have examined the matter in detail and are pleased to accord sanction to open a fixed bank account in the joint name of Principal Secretary, Revenue & Disaster Management and the Head (Scientist), State Emergency Operations Centre and to deposit the presently available funds from non-governmental sources and the funds received as consultancy and management fee for projects funded by non-governmental sources (Project funded by UNDP, UNEP, World Bank, JAICA etc) into this corpus fund subject to the guidelines mentioned above.
