#### **ORDER**

Director, Ministry of Mines, Government of India vide letter read as 1<sup>st</sup> paper above has informed that they were designated as the Central Nodal Ministry to Coordinate with State Governments to mitigate disasters in mines. The Crisis Management Plan for Disasters(CMP) in mines (except coal, Fuel & Atomic mineral) prepared by Ministry of Mines has been provided and the State Government was instructed to constitute State/District level Crisis Management Groups in the State.

As per the direction in the CMP, the Crisis Management Group constituted at the State level will be responsible for dealing with crisis situations and for reporting all developments to the Chief Secretary of the State.

In this circumstance Government examined the matter in detail and constitute the Crisis Management Groups in the State level and District level with respect to mitigation of disasters in mines for the State of Kerala as follows:

## STATE LEVEL CRISIS MANAGEMENT GROUP

- 1. Chairman: Principal Secretary, Industries Department.
- 2. Members:
  - (1)Secretary, Disaster Management Department.
  - (2)State Police Chief or his representative.
  - (3) Director General of Fire and Rescue Service.
  - (4) Director of Health Service.
- 3. Nodal Officer and Member: Director of Mining & Geology.

# DISTRICT LEVEL CRISIS MANAGEMENT GROUP

1.Chairman: District Collector

2.Members:

(1) District Police Chief

(2) District Medical Officer

(3) District Officer of Fire and Rescue Service

3.Convener : District Geologist

The Crisis Management Groups shall meet at least once in every year or as and when required to review the preparedness of various departments for management of crisis in mines and to conduct surprise visits at various mines and also publish annual report on the preparedness to handle the crisis.
