ORDER

As per the e-mail read as 1st paper above, Government of India demanded to create a separate bank account for receiving PM Cares Funds. As per the letter read as 2nd paper above, the Member Secretary, Kerala State Disaster Management Authority has forwarded the bank account details to Government of India (Account Number - 626201092265, ICICI Bank, Thiruvananthapuram Branch, IFSC Code: ICIC0006262 (in the name of MS, KSDMA))

As per the letter read as 3rd paper read above, the Member Secretary, Kerala State Disaster Management Authority has informed that the Government of India has released Rs. 9.685 crores from PM Cares to KSDMA and requested to issue the guidelines for utilisation.

Government have examined the matter in detail and accord sanction to the following:

- 1. Promulgate the guidelines of the PM CARES Fund issued by NDMA, as is
- 2. Authorize the office of KSDMA as the nodal authority of the PM CARES Funds in the State and to create a separate Bank Account in a Nationalized Bank for holding and operating PM CARES Funds.
- 3. Permit the Member Secretary, KSDMA to transfer funds from PM CARES to Districts for the purposes as in the guidelines.
- 4. Permit the District Collectors to open a bank account, preferably linked accounts to the primary account of PM CARES of KSDMA, for receiving

and operating the PM CARES funds

5. Permit the Member Secretary, KSDMA to create a fund disbursement and monitoring mechanism for monitoring PM CARES fund.
