The Inter Agency Coordination led by Sphere India created a common platform for the Humanitarian Agencies to come together and plan their actions avoiding duplication, overlapping and also to have a better collaboration with the District Administration supplementing the state Government relief effort.

**Need for IAG:** Reduce vulnerability and disaster risk of people of Malappuram District through coordination, advocacy and knowledge management, ensuring effective and efficient response to emergencies while ensuring optimum humanitarian standards.

Objectives of IAG:

# **Objectives:**

- To coordinate emergency response initiatives, activation and deactivation of unified response, sharing information and assessments at the time of an emergency, to ensure effective and efficient delivery of emergency relief
- To provide a forum for knowledge management and exchange of information among members and other stakeholders to improve standards and efficiency in disaster response and risk reduction.
- To promote Sphere and other national standards in collaboration with other state and non-state actors through advocacy and collaboration.
- To identify information/data gaps and undertake risk and vulnerability assessments, for more efficient and effective disaster preparedness and management;
- To provide advice and serve as a technical resource for member agencies and other stakeholders
- To make a concrete disaster management plan in the District ensuring proper coordination between Government and NGOs.

The purpose of the IAG Malappuram shall be:

- 1. To provide a forum for coordination among members and with NGOs for professional and effective disaster management in the District of Malappuram.
- 2. To promote the Sphere values and other international humanitarian standards among all the civil society organizations working for disaster management
- 3. To develop and disseminate technical information relating to effective planning and implementation of disaster management program in the District
- 4. To build capacities of subscribing members (and their implementing partners) to undertake joint quantitative and qualitative damage assessment during emergency that could enable member organizations to respond quickly and effectively to emergencies and avoid duplication of efforts.
- 5. To make a detailed Action plan of IAG enabling all members to have the right coordination
- 6. To build a group of trained volunteers at Panchayath level ensuring immediate intervention during emergencies

# Formation of IAG in Malappuram

With the aim of providing a better humanitarian support to the community of Malappuram district during disasters the following 25 NGOs were brought together to the IAG platform for the Malappuram district by the IAG formation meeting held on 15<sup>th</sup> July 2019. An executive committee of twelve elected members were also formed on 15<sup>th</sup> July 2019 for the coordination of IAG activities for a tenure of three years for the well execution of the IAG platform.
