Incident Response System(IRS) is introduced in India 2010 by the National Disaster Management Authority(NDMA).The Guidelines on the Incident Response System(IRS) are issued by the National Disaster Management Authority (NDMA) under section 6 of the DM Act,2005 for effective, efficient and comprehensive management of disasters in India. The vision is to minimize loss of life and property by strengthening and standardising the disaster response mechanism in the country.

Section 22(2),24,30 and 34 of DM Act 2005 have clearly laid down various duties relating to DM to be performed by various agencies. No single agency or department can handle a disaster situation of any scale alone. Different departments have to work together to manage the disaster. For proper coordination and effective use of all available resources, different departments and agencies need a formalised response management structure that lends constituency, fosters efficiency and provides appropriate direction during response. Response Management constitutes the functions of planning, execution and coordination.

In the above circumstances I Mehrali, District collector (in charge) and DDMA chairman Malappuram hereby designate the following officers as functionaries of Incident Response System (IRS) in Malappuram District as per section 30 of Disaster Management Act 2005.
