#### A. About the Virtual Cadre Training Programme

The State Disaster Management plan 2016 of Kerala envisages setting up a virtual cadre for all departments in which officials from different departments will be trained to act as respondents to disaster management related issues. Hence, the idea of creating human resources groups within the departments becomes a necessity. **Govt. of Kerala vide GO Rt no. 56/2017/DMD dated 25th November 2017 and vide GO Rt No. 111/2018/DMD dated 28th February 2018** issued under the section 16 of DM act 2005, had formalized the virtual cadre for officials from 26 departments.

The virtual cadre will support the departments in carrying out the following activities

- 1. Support to District Disaster Management Authority (DDMA) in preparation of District Disaster Management Plan (DDMP)
- 2. During emergency, support DDMA and work with the departments
- 3. During emergency inform the directions and decisions taken by the SEC and coordinate with district level line departments
- 4. Develop and update departmental disaster management plans as envisaged in the National Disaster Management Act (2005).
- 5. Prepare training calendar for district and assure necessary arrangements for training
- 6. Provide necessary support and advice to departmental heads and make sure that the activities under the departmental plan are not resulting in increase of disaster risk and
- 7. Implement projects of the DDMA pertaining to the concerned departments.

As part of this ongoing engagement, officials from eight departments were trained in the year 2019-2020 by Kerala State Disaster Management Authority. For 2020-2021 this engagement focuses on the virtual cadre training for officials on disaster risk reduction (DRR) from 7 departments of Kerala government. These departments include:

- Fisheries
- Groundwater
- Panchayat
- Education
- Civil Supplies
- Tourism
- Local Self Government (Planning)

As the first step towards executing this programme, an inception meeting was conducted on 24th November 2020 from 3pm to 4.20 pm for six departments namely panchayath, civil supplies, education, tourism, ground water and fisheries. In the inception meeting the relevance of virtual cadre for DM and the Training needs assessment format were explained. As a follow up, the meeting report along with the training needs questionnaire was send to heads of all departments as well as the virtual cadre members to respond. As per the request from LSG planning department for training in DM and risk informed planning, it was decided to include officials from these departments also for the training session. An inception meeting and training needs assessment was done for this department on 7th April 2021 from 11am to 1pm. In the mean time modules for training the departments and equipping them for the formulation of departmental DM plans were designed and reviewed with the help of AIDMI and experts from KSDMA team.

A Training Needs Assessment (TNA) dissemination meeting was conducted online on 23rd June 2021 in order to inform the virtual cadre members about the findings of the TNA. Further, main online training session is being planned for 5 days with two hours online sessions each day.

#### B. Five Day Training for Groundwater Department

As mentioned above, a 5-day training on Disaster Risk Reduction (DRR) was conducted for the virtual cadre officials of the Groundwater Department. The first 3 days of this training were held from 5<sup>th</sup> July-7<sup>th</sup> July 2021 (14:30-16:30 hrs) and focused on general and basic training on DRR. Basic concepts, legal and institutional mechanism, Kerala profile – Disaster Management, case studies and best-case scenarios etc. The last 2 days of this training were held on 22<sup>nd</sup> July-23<sup>rd</sup> July 2021 (11:00-13:00 hrs) and focused on generated with DRR.

During these training sessions, the participants were given orientation on various aspects of disaster risk reduction and also on how to mainstream disaster risk reduction in their departmental level activities. Throughout the training sessions, there was a high degree of engagement between the participants and the resource persons.

Most importantly, the participants were trained on how to draft a 'Departmental Disaster Management Plan'. Preparation of Departmental DM plan is an important outcome of this training

as it is aligned with the mandate of the National Disaster Management Act (2005). Section 41 of National Disaster Management Act (2005) envisages the formulation of departmental DM plan by the virtual cadre officers of each department. After the completion of this training, the participants are now expected to draft their respective department's DM plan and submit it to KSDMA for review.






1. How was today's training session? 10 responses



2. How were trainers of this training session? 10 responses




3. Did you understand the importance of disaster management for the groundwater department? 10 responses



1. How was today's training session? 10 responses




2. How were the trainers for today's sessions? 10 responses
