Background

State Government constituted State Disaster Mitigation Fund as per the letter No.33-02/2020-NDM-I dated 14th January 2022 regarding the Guidelines on the Constitution and Administration of the State Disaster Mitigation Fund based on the recommendation of the fifteen Finance Commission 2021-22 to 2025-26. The State Disaster Mitigation Fund is a source for the implementation of disaster mitigation projects through local self-governments and field departments, and not all the projects can be funded under SDMF. The proposal received by the Government is not in tune with the extant guidelines issued by the MHA, Government of India. Some of the departments requested to arrange an awareness session in this regard also. In order to provide awareness on projects that can be undertaken under SDMF, an online orientation programme was scheduled to be held on 16-5-2023, 10.30 am via online.

Objectives of the consultation meeting

- To familiarise the guidelines of SDMF/NDMF
- To receive project proposals based on the guidelines.

The orientation programme started at 10:30 am. Dr Sekhar L Kuriakose, Member Secretary, Kerala State Disaster Management Authority, welcomed all the officials and explained the programme's objectives. The Member Secretary provided a detailed explanation of the guidelines of SDMF, templates of the proposal of projects and some examples of projects that can be implemented.
