KSDMA Talk Series

Session 1: “*Mangrove Restoration and Conservation in Kerala*” - By Mr. Anandan Pokkudan

Mr. Anandan Pokkudan, Mangrove Conservator, Kallen Pokkudan Mangrove Tree Trust is the son of Mr. Kallen Pokkudan recognised as “The Mangrove Man of India”, who was one of the pioneers of environmental activities and an environmentalist who worked at the forefront of protecting mangrove forests, known as the Lungs of Nature, in Kannur district and later worked and spread awareness in many places in the State.

In this Session, he shared about his father’s journey in the conservation of these mangroves and the hurdles faced from the various sectors as well. During the initial phase he searched for mangrove seeds and had chosen Rhizophora and collected long stick-like seeds of this plant and planted the mature seedlings along riverbeds and public spaces in his village. He had set up a mangrove nursery and organized awareness campaigns.

He conveyed about the importance of seed selection and how to generate a good seed after exposing to the wind action, about the importance of soil in Kerala, protection of coastal regions by mangrove covers as a natural solution, how it is helping fisherman society and how it helps in development of marine ecosystem and its role in food chain, how it acts as shelter for migrant birds, how it acts as a sea wall etc. He had shared his concern that even if there is a wide scope of development in this field, concerned authorities are not concentrating for the

nature-based solutions that mangroves offer for the various disasters that our land had faced during the years.

The session was followed by a Vote of Thanks by Ms. Amrutha K. HA (Env.).



Session 2: *“Organic Paradise in Kerala - A true Model”* - By Ms. Vani Vijith



Ms. Vani Vijith


Ms. Vani Vijith is a natural eco farmer, Environmental Activist and Co-founder of Prakrithi Jaiva Kalavara, Ruchira Prakrithi foods, Vasu Jaivaganam in Danapady, Haripad, Onattukara Region Agro ecological zone, Alappuzha District, Kerala. Mr. Vijith & Ms. Vani Vijith had proved that sustainable living is not impractical and are living in harmony with nature.

With the strong desire for agriculture which was inherited from her family had moulded her in building up a sustainable ecosystem in such a way as we see now. In the 4.5-acre sustainable farmland at Vani's native place at Haripad, we can see over 5,000 trees, over 3,000 varieties of vegetables, fruits, rare plants, medicinal herbs, ornamental plants, 32 bamboo variants, various breeds of cows, goats, hens, duck, fish, birds, dense kaavu, three biogas plants, solar plants, nine ponds and a rooftop rainwater harvesting system. Following the traditional practices of mixed farming and applying organic manure and compost for the crops, had helped them to fight pest attack. She had conveyed the struggles faced from her family in dropping her chance for getting a degree in medicine for her urge in agriculture.

She had shared her experiences and struggles faced in attaining her passion and in dropping her chance for pursuing degree in medicine. With her strong desire she was able to face all the hindrances in the path of life.

She had shared the scope, concept and challenges in sustainable agricultural practices from her experience being an organic farmer and also exchanged information about development of agricultural land and farmland, water resources, Irrigation/ Drainage Management, Agricultural Diversification for agricultural development, indigenous and endangered crop cultivation, sustainable development, aerobic composting for Carbon Sequestration, integrated farming system, biodiversity conservation, micro climate regulation, preservation of endangered species of flora and fauna etc. It was really enthusiastic to hear about the attainment of 17 sustainable development goals through their hardwork and her dream to attain Sustainable Agricultural Goals like Geriatric – Paediatric linkage with horticulture therapy, responsible farm tourism, Social Assets formation, Eco-spirituality, Self-Reliable, Self-Sustainable Agricultural practices, evolution of nutraceuticals through sustainable value-added agricultural products.

The session was followed by a Vote of Thanks by Ms. Amrutha K. HA (Env.). The program concluded at 4.30 PM.



The Way Forward: -

World Environment Day serves as a catalyst for future environmental sustainability initiatives and in promoting environmental protection. Knowledge sharing programs about various environmental aspects through talk series, webinars, workshops, conferences, site visits, conducting events and campaigns from the perspective of disaster resilience can be organised in future in KSDMA, DDMA's and for public as well. Disasters in one way or the other has direct or indirect link with the environment. Environmental disasters can have a lessening effect with increased knowledge and awareness.
