ORDER

Having taken into account the conditions due to heat wave and severe temperature exceeding 30 degree Celsius in parts of Idukki District and the ground level report of crop loss in the district received from District Disaster Management Authority, the State Government has decided to declare heat wave of severe nature in the affected villages of



Idukki District in the State. The list of heat wave affected villages is enclosed as Annexure to this Government Order.

The declaration of heat wave has effect from 1-4-2024 and would continue to be in effect for eight months from this date as the impact of heat wave and extreme temperature have significantly impacted the economic well being of farmers of the above villages and replanting has become essential for various crops. Government hereby authorizes the District Disaster Management Authority of Idukki to undertake relief measures in the notified area. A formal gazette notification will be issued subsequently.
