**ORDER**

As per Govt. Letter read 1<sup>st</sup>, Govt have accorded sanction to Kerala State Disaster Management Authority to recruit for the posts of Operators (Nos-6) and Supervisor (nos-1) on contract basis in the project namely "Extension of Emergency Support Response System (ERSS)" from Sainik Welfare Board or from open market through notification and transparent selection process in case it is not able to provide necessary Human Resource.

Subsequently, on demand, by fulfilling the criteria, as per the request from this office, vide 2nd cited, the Director, Sainik Welfare, has provided the list of 25 eligible candidates for the post of Operator for filling the vacant post of 1 Operator in the project.

On the basis of the above, an internal selection committee has also been constituted for conducting the interview amongst the selected applicants and accordingly, the internal selection committee has conducted the interview of shortlisted candidates on 21/10/2024 and submitted the list of evaluation by mentioning the rank of each candidates for the post of Operator in the project - Extension of Emergency Support Response System (ERSS).

In the above circumstances, the rank list prepared for the posts of Operator under the project Extension of Emergency Support Response System (ERSS) is here by approved and sanction is accorded to appoint the selected candidate on contractual basis in the concerned vacancy for a period from date of joining of the candidate to 31/08/2025 (the date of end of the project) as detailed in the Annexure to this order, subject to the following conditions :

1. The duties and responsibilities of the appointees will be determined by the Member Secretary, KSDMA & Head, SEOC
2. The monthly consolidated pay of Operator is ₹. 18,000/-
3. The appointee shall execute an agreement with KSDMA in a standard format as applicable to contract employees in non-judicial stamp paper worth ₹. 200/- or (e-stamping as applicable).


