The National Disaster Management Authority (NDMA) vide paper read as 1 st above had issued guidelines on the implementation of Incident Response System (IRS) with the vision to minimize the loss of life and property by strengthening and standardising the disaster response mechanism in the country.

As per this guidelines, the Incident Response System (IRS) in Malappuram Disrtict has been constituted vide second paper read above.

The IRS as an effective mechanism for reducing the scope for ad-hoc measures in response. It incorporates all the tasks that may be performed during Disaster irrespective of their level of complexity. It envisages a composite and comprehensive team with various sections to attend all the possible response requirements. The IRS identifies and designates officers to perform various duties in their respective roles. The IRS organisation functions through incident Response Team (IRT) in the field.

As per the guidelines read as paper 3rd above, all District Disaster Management Authorities, shall notify/reconstitute the incident Response System in the District and all Taluks including alternative officers for each category.

In these circumstances, the Incident Response System of Malappuram District is hereby reconstituted as under section 30 of the Disaster Management Act 2005.
