As per the 1st paper read above, Ministry of Finance has approved the project submitted by the state under SASCI and released an amount of Rs. 529.50 crore under Part-I (Untied) of SASCI 2024-25. Out of which an amount of Rs. 28 crores is allotted for constructing multipurpose shelters (Rs 3.5 crore for each shelter).

As per the 2nd paper read above, Chief Engineer, Public Works Department (buildings) has submitted an estimate for an amount of Rs. 350 Lakh for the works "Construction of Multi purpose Shelter at Mullankolly in Wayanad District". The proposed building is G+1 having plinth area of 700.62 sq m. This estimate was prepared using PAR 2019 to facilitate the administrative sanction. Chief Engineer, Public Works Department (buildings) has proposed to be arranged the work in EPC mode due to urgency.

Government have examined the matter in detail and are pleased to accord administrative sanction for the works Construction of Multi purpose Shelter at Mullankolly in Wayanad District for Rs. 350 lakhs and execute on EPC mode of contract, on the condition that Technical Sanction shall be issued by the competent authority for each project (Based on standard specifications
