Virtual Meeting organized by NDMA with SDMA's on MHPSS framework and its implementation

Details of the Event	The National Disaster Management Authority (NDMA) convened a virtual meeting with representatives from the State Disaster Management Authorities (SDMAs) of the 12 States and 2 Union Territories identified for the rollout of the National Programme on Mental Health and Psychosocial Support (MHPSS). The primary objective of the session was to sensitize and orient the nominated State/UT Nodal Officers about the national framework, implementation roadmap, and operational expectations for the MHPSS Programme. The meeting was led by Shri Krishna S. Vatsa Member, NDMA, supported by Ghanishta Suri, MHPSS Consultant at NDMA, Dr. Chetna Duggal from TISS-Rahbar. A major component of the session was the presentation by Dr. Chetna Duggal, who elaborated on the four-phase implementation structure to be followed by the States/UTs: 1. Phase I - Orientation: This phase involves sensitizing SDMA members and key state-level stakeholders on the concepts of Mental Health and Psychosocial Support, the MHPSS pyramid, community-based support mechanisms, and the importance of integrating psychosocial considerations into disaster management frameworks. 2. Phase II - Pre-Disaster Assessment: NDMA, in collaboration with TISS Rahbar, will conduct a detailed predisaster MHPSS assessment across the selected States and UTs. A separate workshop will be organized for SDMA officials to train them on the assessment methodology, data collection processes, tools, and reporting formats. States are expected to complete the assessment and submit the final report to NDMA for review and further action. 3. Phase III - Capacity Building and Training of Trainers (ToTs): Dr. Duggal also outlined the modules to be covered during the ToTs, such as

	integrating MHPSS into disaster response, specialized and non-specialized psychosocial support services, trauma-informed care, and strengthening community-level capacities. Some of these ToTs, especially those focused on mental health professionals, will be conducted by NIMHANS. 4. Phase IV – Monitoring, Outreach, and Refresher Trainings: This phase includes biannual monitoring of MHPSS activities by States, dissemination of Information, Education and Communication (IEC) materials, and conducting online refresher training sessions for previously trained personnel.
