Disaster Management Department- Procurement of 250 Laptops for the School Children affected by the landslide at Meppadi Panchayath on 30-07-2024– Administrative Sanction Accorded – Orders Issued.

ORDER

As per the letter read as 1st paper above, District Collector, Wayanad requested for 250 laptops to distribute to school children who have been affected by the landslide occurred on 30-7-2024 at Meppadi Panchayath in Wayanad district.

2) As per the letter read as 2nd paper above, Member Secretary, KSDMA reported that Communication Engineer of KSDMA had evaluated various configurations of laptops considering their use and longevity and requested M/S Keltron to submit suitable models for the use of school children with onsite 3 year warranty for the laptop, battery and adapter. Accordingly, M/S Keltron submitted a proforma invoice containing the costing of two models of laptops.

The makes, models and the costs proposed by M/S Keltron was evaluated by DDMA Wayanad and recommended the make and model:Dell VOSTRO 3250 + onsite 3 year warranty for the laptop, battery and adapter. The cost of one laptop is Rs. 42,810/- and the total

cost for 250 units will be Rs. 1,07,02,500/-(inclusive of GST).

3) The State Executive Committee of KSDMA held on 31/01/2025 considered the matter and in principal approval was given for meeting the expenditure for the procurement of laptop from the CSR fund of KSDMA. The SEC has also directed to examine the offer of HCL and ITC for procuring Chrome book or laptop before effecting the procurement and submit the revised proposal to the Disaster Management Department.

4) As per letter read as 4th above Member Secretary has informed that the proposed specifications are not available in CPCRS and has requested to accord sanction to purchase laptops of make and model "Dell VOSTRO 3250" for a total cost of Rs. 1,07,02,500/-.

4) Government have examined the matter in details and are pleased to accord sanction for the procurement of 250 laptops of make and model "Dell VOSTRO 3250" with an onsite 3-year warranty for the laptop, battery, and adapter through M/S Keltron, for a total cost of Rs. 1,07,02,500/- by utilizing funds from the State Disaster Mitigation Fund (SDMF-CSR Contribution). The final price shall be negotiated and fixed with M/s Keltron by KSDMA, before placing purchase order.
