## **ORDER**

As per the letter read as 2nd paper, Government of India has released an amount of RS. 529.50 Crores under the "Special Assistance to State for Capital Investment (SASCI) scheme" for the implementation of various projects in landslide affected areas of Meppadi, Wayanad districts. Implementing agencies of the projects includes Public Works Department, Kerala Water Authority, Kerala State Electricity Board and Irrigation Department.

As per GO read as 24<sup>th</sup> paper above, Government have designated Disaster Management Department as the Single Nodal Agency (SNA) for the implementation of the scheme as per the existing guidelines. Accordingly, Disaster Management Department has opened an SNA account in the SBI, Main branch Thiruvananthapuram and directed implementing agencies to open SNA child accounts under the main SNA Account.

As per Government Order read as 3rd to 23rd papers above, Government have issued administrative sanction for a total amount of Rs. 322.94 Crore for various works approved under SASCI scheme.

In this circumstances, sanction is accorded to the Finance officer, Disaster Management Department to allot the fund to the SNA child account of the implementing agencies as mentioned below;
